Letter to New Registered Shareholders

— Election of Language and Means of Receipt of Corporate Communications

To make your election, please complete and sign on the enclosed reply form (the “Reply Form”) and return it to the Company c/o the Company’s Share Registrar, Computershare Hong Kong Investor Services Limited at 17M Floor, Hopewell Centre, 183 Queen’s Road East, Wanchai, Hong Kong by post using the mailing label at the bottom of the Reply Form (a stamp is not needed if posted in Hong Kong) or by hand delivery.

If the Company does not receive the duly completed and signed Reply Form or receive no response from you indicating your objection to access the Corporate Communications through the Company’s website or the HKEx’s website by 17 September 2013, you are deemed to have elected the Website Version and we will send you the Company’s printed notifications (as referred to in the first paragraph above) by post to your address appearing in the register of members of the Company maintained by the Company’s Share Registrar.

You may send your request (specifying your name, address and request) at any time by reasonable notice in writing to the Company c/o the Company’s Share Registrar or via email at aia.ecom@computershare.com.hk to change the choice of language or means of receipt of the Corporate Communications. Even if you have elected (or are deemed to have elected) to receive all Corporate Communications by electronic means but for any reason you have difficulty in gaining access to the Corporate Communications on the Company’s website, the Company will promptly upon your request send the Corporate Communications to you in printed form free of charge.

Please note that printed copies of the English and Chinese versions of all Corporate Communications will be available from the Company or the Company’s Share Registrar on request, and both versions will also be available on the Company’s website at www.aia.com and the HKEx’s website at www.hkexnews.hk.
