If the Company does not receive your duly completed and signed Reply Form or receives no response from you indicating your objection to access the Corporate Communications through the Company's website or the HKEx website by 23 April 2014, you are deemed to have elected the Website Version. We will only send you the Company's printed notifications (as referred to in the first paragraph above) by post to your address appearing in the register of members of the Company maintained by the Company's Share Registrar.

You may send a request (specifying your name, address and request) at any time by reasonable notice in writing to the Company c/o the Company's Share Registrar or via email at aia.ecom@computershare.com.hk to change the choice of English or Chinese language or means of receipt of the Corporate Communications even if you have elected (or are deemed to have elected) to receive all Corporate Communications by website, the Company will promptly upon your request send the Corporate Communications to you in printed form free of charge.

Please note that printed copies of the English and Chinese versions of all Corporate Communications will be available from the Company's Share Registrar on request, and both versions will also be available on the Company's website at www.aia.com and the HKEx website.
